COLLECTION OF PERSONAL INFORMATION

Information collected directly from you:

NOVAworks may collect personal information directly from you, for example during the registration process, while scheduling appointments or registering for workshops or events, through a web-based form, or in receiving or responding to email or text-based communications. Personal information we collect directly from you may include first and last name, address, email address, and phone number; if registering for NOVAworks services, we will collect additional information, such as Social Security number, birthdate, and previous work history.

Information collected from your device:

Our website may use technologies such as cookies, web beacons, pixels, and other similar technologies to automatically collect certain information from your device including, for example, your IP address, date and time of your visit, browser and operating system information, referring website address, and other information about how you interact with the website. Our email campaigns may also use tracking technologies such as web beacons, pixels and other similar technologies to automatically collect certain information such as your IP address, browser type and version, and email engagement statistics.

USE OF PERSONAL INFORMATION

We may use information collected about you for any lawful purpose, including the following:

- to provide you with services, customer service and support, and other relevant information;
- to comply with the law and to maintain the security of our website; or
- with your consent, or as otherwise disclosed at the time information is collected.

DISCLOSURE OF PERSONAL INFORMATION

We are required to share your information with both the State of California and the U.S. Department of Labor when you register for NOVAworks services. Some information may also be shared with Constant Contact, if you choose to receive or respond to email or text-messaging communications.
